# Omaha City Council Approves New Solid Waste Contract Cans will be out, carts will be in.

The Omaha City Council voted Carts 4-3 to award the city's next solid waste contract to FCC Environmental at its

August 27 meeting. The contract will modernize Omaha's collection process by using wheeled carts with lids and trucks that automate collection, bringing the city in line with the industry standard for collection. The changeover will take effect on or before January 1, 2021.

FCC was one of four companies that bid on the collection contract. A working group met in May and provided their evaluation of the bids to Mayor Stothert.

Mayor Stothert answered questions from the media about the city's new solid waste management contract.

As part of the contract, each household will receive two 96-gallon carts: one cart for combining garbage and yardwaste that will be picked up weekly, and the other cart for recycling that will be picked up every other week. Responding to public testimony at the City Council hearing, a separate contract to enhance vardwaste collection during the heavy seasons in the spring and fall was bid.

With this separate contract, two short unlimited yardwaste collection periods (6 weeks each) will help with the rapid grass growth in the spring and the falling leaves in the fall.



As part of the new contract, you will receive two 96-gallon carts with wheels and attached lids.

If there are five or more persons in your household, you can apply for a third cart at the city's expense.

Over the months between now and when FCC starts collection, there will be several issues of Wasteline to bring you up to speed. But for now, it all starts with the biggest change — the cart! Take a look on page two, where we take a deep dive into the cart. Future issues will focus on other important topics.

"The main thing we want people to know is there's plenty of time to prepare everyone for the change and deal with issues that come up," said James Kee, Environmental Quality Control Manager for the City of Omaha.

## The New Carts: Separating Fact from Fiction

🕠 Carts

There are a lot of questions about the City of Omaha's

recently approved solid waste collection contract with FCC Environmental. So many questions, in fact, that it will take several issues of *Wasteline* to explain everything. For now, it's all about the cart, the central feature and most dramatic change for residents with the new contract.

#### **The Basics**

Using the cart will be the only way your waste and recycling will be collected. Carts have been the industry standard for many years. It's finally become time for the City to make the big investment in carts.

The standard issue for each household will be two 96-gallon carts — one cart for recycling and one cart for garbage and yardwaste combined. If you think this size is too big, an optional half size cart, 48-gallons, will be available after you try the standard issue cart for 90 days. This half size cart will be available from the beginning for elderly/handicapped households registered for Special Collection (see page 4).

96 gallons means you've got three times the volume compared to the 32-gallon trash can used now. The 96-gallon cart will hold 7, yes 7, kitchen size trash bags of waste (one for every day of the week).



Weight limits are (nearly) a thing of the past — the 96-gallon cart has a load capacity of more than 300 pounds. But let's not take that as a challenge; remember to reduce, reuse, and recycle!

Carts are rugged and will withstand harsh weather. Carts may be left outside but not at the curb. Find a convenient location near your home or in your garage. Maybe plant a bush, or build a small fence to hide the cart if it's required by your neighborhood association.

Carts are easy to roll because of their 10-inch wheels and have a hinged lid that won't get lost or destroyed. The lid will keep things dry, flies out, and deter many critters.

A side benefit of carts is how they will make neighborhoods more attractive on collection day. Streets will have a uniform look instead of a mix of trash cans, bags, and bins.

Carts will be delivered several weeks to several months before collection begins. Omaha is big — 300,000 carts big — so it takes time! The carts will be delivered with an information packet and a start date.

# Big but sometimes not big enough...

If you're a family of five or more, you qualify to apply for an extra cart paid for by the City. If your family isn't large enough to receive the additional City-supplied cart, FCC will lease you an extra cart for \$91 per year. Extra carts are only available through FCC. Look-alike carts sold in stores won't have the right logo on the side and won't get collected.

## Nitty gritty details

The carts will be owned by the City, and you will be responsible to care for the cart. Normal wear and tear is expected, but willful damage will mean you must take responsibility for repair or replacement.

Carts have a serial number and an electronic tag so it can be returned to the correct home if relocated. The electronic tag helps us understand how collection is going in real time.

The carts will be black, which means they can be made from a significant amount of recycled plastic. When the cart does wear out, it too is recyclable.

# Mulching and Blowing Viable Options to

**Raking Fall Leaves** 

It won't be long before Omaha's tree canopy begins to change color, and we all know what comes next. For many a homeowner, raking your fall leaves is still the way to go. It's a great way to get some exercise while being outdoors and initiate conversations with neighbors out doing the same thing.

If you have access to a mulching mower, consider using it to shred your leaves without bagging. The decomposing leaves and grass cover the soil between the individual grass plants where weeds like to germinate. Mowing may take two passes, in perpendicular directions to get acceptable results.

Studies by Michigan State University Cooperative Extension have found that after several years of mulching leaves, it resulted in a reduction of dandelion and crabgrass weed germination. The benefits of mulching are many:

- It's easier on your back
- It's faster than raking.
- You end up spending less money on weed control products.
- Mulched leaves keep the soil warmer in the winter and cooler in the summer.
- The nutrients provided by mulching reduce the amount of fertilizer needed to achieve green-up in the spring (if you do that kind of thing).

If you've got a blower, you can blow your leaves into landscaped beds or use a lawn vacuum to suck them up. Leaf vacuums produce finely chopped leaves you can use to cover your flower or vegetable beds for winter.

No matter which method you choose, get those leaves off your lawn before winter hits. Layers of leaves covered by rain and early snows create soggy (not to mention heavy) mats that block air and sunlight from reaching the grass.

## Recycling



Want to recycle? You must use a green recycling bin. Need one?

Pick up a recycling bin from one of the locations listed to the right.

#### Got clean paper?

#### Recycle it!

This includes catalogues, cereal and detergent boxes, paper egg cartons, greeting cards, junk mail, magazines, newspapers, phonebooks and wrapping paper. To help prevent litter, place all your clean paper in a paper bag or small cardboard box, then lay it inside or next to your green bin with the opening facing away from the wind.

#### Got corrugated cardboard?

#### Recycle it!

Break it down and place it under your bin. If you have a lot of boxes, fold and stuff multiple boxes into one box and place it next to your bin. Easy!

#### Got empty containers?

#### Recycle it!

You can place all gable top and aseptic cartons (juice boxes and cartons, milk cartons, and soup or broth boxes) loose in your bin. The same goes for aluminum and tin cans, including empty aerosol cans and empty and dry paint cans with the lids removed. Place the top of food cans inside the can and crimp them closed.

#### Got plastic containers and packaging marked with a ව ව ව ව ව.

#### Recycle it!

This includes bottles, clamshell deli containers, cookie trays, cups, clear plastic packaging, DVD cases, microwave meal trays and snap-top containers. Squeeze out some of the air to prevent litter and fit more in your bin. Keep lids/caps on bottles.

## **Yardwaste**



Place yardwaste within 5 feet of your collection location. Leave 2 feet of

space between yardwaste and garbage containers.

- Grass clippings and leaves
- Garden waste such as fallen apples, rotted or excess vegetables and fruit
- Trash cans up to 32-gallon that weigh up to
- Special yardwaste paper bags that weigh up to 40 pounds
- Unlimited number of properly prepared marked cans, paper bags or brush bundles
- Bundles of branches and brush, tied with string or twine. Bundles may weigh up to 30 pounds
- Branches may be up to 2 inches in diameter and 4 feet in length

- · Plastic bags used in yardwaste collection
- · Mixtures of yardwaste and garbage
- · Items sticking out above the can
- Sawdust, lumber or treated lumber/wood
- Litter, trash, or garbage
- · Whole cans of dirt or sod
- · Street sweeping sand, litter, or rocks
- Cardboard boxes of yardwaste
- Pet waste or kitty litter
- · Branches over 2 inches in diameter or over 4 feet long
- · Plastic twine, nylon twine, wire or rope of any kind
- · Brush that is not bundled
